Public Hearing For 2010-2011 Budget & Tax Rate Debbie Monschke presented an overview of the proposed 2009-2010 budget. The maintenance and operation budget is \$193.1 million, which will have a \$2.83 budget deficit. The revenue includes \$82.17 million in state aid, compared to \$85 million the district received from the state for the 2009-10 school year. This is a \$2.82 million decrease from the previous year. The debt service budget is \$45.7 million, a \$2.3 million increase from last year. This could possibly

increase the debt service tax rate from 45 cents to 49 cents to provide a balanced budget.

Mr. Kenneth Stout addressed the Board regarding the proposed budget.

Energy Management Report John Taylor, TD Industries representative, reported the district spent \$3.5 million on utilities this year, compared to \$3.9 million last year. This is a decrease of \$569,538 for the first six months of the school year. The decrease included a cost increase from the opening of the Virginia Gallian Child Development Center and 187,695 square feet of new space in existing district facilities.

Paul Andress, Director of Maintenance introduced Phil Williams with Denton Municipal Electric and Bill Bunselmeyer with the City of Denton. They presented the Board with a rebate check for \$55,735 due to lighting retrofits DISD has implemented.
