# C. Approval of Memorandum of Understanding of United ISD's commitment to STARS Scholarship Fund

**Gloria S. Rendon:** Good evening board members. We want to bring you a proposal from the individuals that manage that organization. We were recently approached to see if the district would conquer in promoting the Partners for Scholars partnership program that we currently have for our students with the opportunity of hopefully double the amount of either the individuals that we provide scholarships for or the

amount that is given to them. We currently give \$1000.00 from our Partners for Scholars program. The STARS individuals who came to meet with us are asking for a commitment from us regarding our Partners for Scholars Funds. There are about 24, 25 Universities and Colleges across the State of Texas that would match the Scholarship that is provided to these individuals through the STARS Scholarship Foundation. So we give a recipient \$1,000.00 and the College that they choose to go to will match another \$1,000.00. Or we can give them \$500.00 and propose that the college that they choose will match the other \$500.00 for a total of \$1000.00.

So we thought it was a good opportunity to expand on the number of individuals that we can provide a scholarship to. So we're not committing all of the funds because there is certain criteria that has to be met by each of our student through the STARS Scholarship program. That is that they would need to have 12 dual class credits already taken at the High School level. The other item is that they would have them take an AP assessment that they would score high on as an opportunity for them as well. So we are asking for the MOU to be signed this month and then we can go and continue establishing our criteria for the STARS Scholarship program and those will be presented.

Steve Lamantilla was the individual who came to us and proposed this and we think it's a really good opportunity. We normally collect between \$150K to \$180K for Partners for Scholars but we are not committing to all of these funds. We are looking to commit to about \$100K dollars and using the rest of the funds for individuals who don't necessary meet that criteria, and we would still have some funds available to offer other students scholarships from our Partners for Scholars.

Ramiro Veliz: And we're trying to finalize the criteria before the end of the year?

Gloria S. Rendon: Yes sir, before we start granting those scholarships.

**Roberto J. Santos:** We would probably be coming back December or January to finalize the criteria because we also have to make sure that we include the criteria that they are asking for.
