On April 22, 2026, seven (7) bids were received and opened publicly for the District's copy paper needs for the 2026/27 school year. The bid notice was published in the Daily Herald on March 12, 2026. Bids were received from Contract Paper Group, Veritiv Operating Company, Liberty Paper, Midland Paper, Taza Supplies, Inc., Staples Business, and Murnane Paper Company.

It is the recommendation that the Board of Education accept the bid from Contract Paper Group at a unit price of \$28.35 per case for a total cost of \$24,948.00 for 880 cases. This represents a 2.057% increase over 2025/26 pricing of \$24,445.20. A summary of the bids is attached for your reference.
