DISCUSSION: Independent audit services are required to perform an audit

board policies for procurement procedures.

The cost of the one-year renewal is \$100,000.00 which is budgeted in the Business Administrative Department's FY 2018-19 operating budget and subject to Board approval for the products and services described and in accordance with Board Policy CF (Local) and Texas Education Code Section

44.031.
