Scope of work to include:

- Provide labor and material to install One (1) HES 9400 electric strike on Nurse's door.
- Provide labor and material to install One (1) HES 4500C electric strike on Vestibule to Office door.
- Provide labor and material to install Two (2) Alarm Controls TS-18 door release buttons at Reception.
 - One (1) to unlock Office to Vestibule Door
 - One (1) to unlock Nurse's Door
- Provide labor and material to install One (1) Axis P3265-LVE network camera at Main Entrance Door.
 Includes device license
- Provide labor and material to install One (1) Axis M3088-V network camera in main vestibule.
 - Includes device license
- Provide labor and material to install One (1) network data drop at each of the above camera locations.
- Provide labor and material to install One (1) Aiphone JPS-4AEDV kit.
 - Includes door station, master station, desk stand and power supply.
 - Provide labor and material to install One (1) Aiphone JP-4HD substation.
 - Includes cabling from master to station
- Provide labor and material to install Two (2) Rosslare AY-K35 card readers.
 - One (1) at the Vestibule to Office door
 - One (1) at the Vestibule to Nurse door
- Provide labor and material to install One (1) Rosslare D-805 door expansion board in existing enclosure.
- Provide labor and material to install all necessary access control cabling to above doors.
- Provide labor and material to install all necessary wiremold at above locations.
- Provide labor to aim and focus camera with customer.
- Provide labor to program new doors into existing Rosslare access control system.
 - Assumes system has capacity for programming additional doors.
- Provide labor to test doors with customer.
- Provide open-air pathways using j-hooks and EMT conduit sleeves thru any walls where necessary, fire stopping and installing all according to the BICSI 568 B building standards and/or the National Electrical Codes.

Excludes:

- Allowances for 110VAC power wiring or cable trays.
- Network connection with ISP.
- UPS backup.
- Lift rental.
- PoE network switches, network electronics and PC's except where specified.

Work is to be performed during a standard 8-hour workday between 7:00 AM and 3:30 PM, Monday through Friday. Payments are due every 30 days as the work progresses. A 1.5% service charge will be applied to all outstanding account balances over 30 days past due.

added respectively. All excavation spoils are to remain on site. If included in bid for removal is based on CLEAN, Non-Contaminated soil removal and does not include remediation or special hauling fees, treatment charges and special permits relating to contaminated soils. Owner/General Contractor is responsible for all excavated areas if not specified and included in the scope of work.

Non Solicitation of Employees

By acceptance of this proposal, customer agrees not to directly or indirectly recruit, solicit, hire or induce any employee of Tri City Electric Company or any affiliate thereof, to terminate his or her employment with Tri City Electric Company. This restriction does not apply to solicitation of any employee of Tri City Electric Company or any affiliate thereof, who Tri City Electric Company has terminated due to job elimination or reduction in work force. Contractor agrees that it must obtain written consent of Tri City Electric Company prior to hiring any such Tri City Electric Company employee. The duties, objections and restrictions set forth in this paragraph shall expire upon the first anniversary of the conclusion date of the engagement contemplated in this proposal.

Force Majeure

If the Subcontractor is delayed at any time in the commencement or progress of the Work by diseases, epidemics, pandemics, including but not limited to labor or material shortages, unusual delay in deliveries, restrictions on access or travel, unavoidable casualties or other causes beyond the Subcontractor's control, then the contract times shall be extended. Given the volatility in material and equipment costs, as well as delivery dates, due to issues outside our control or because of unforeseen events, such as national port union strikes, our pricing is based on current market conditions at the time of this proposal. Should our material costs increase or delivery dates change as a result of such disruptions, we reserve the right to adjust the contract price and/or receive an extension of time due to delayed delivery dates accordingly.

Other Terms

TCE is proposing a price for the scope of its work based on the assumption the parties will execute a commercial reasonable subcontract agreement, such as an unmodified Consensus DOC 751, Short Form Agreement between Contractor and Subcontractor, or AIA A401, Standard Form of Agreement between Contractor.
