
Dear Dr. Hardwick:

WHEREAS, Beeville Independent School District wishes to eliminate the discount on early payment of District taxes, as authorized by TEX. TAX CODE § 31.05;

WHEREAS, under TEX. TAX CODE § 31.05, the governing body of the Beeville Independent School District is empowered to authorize the elimination of the discount in the manner required by law for official action by the body;

NOW, THEREFORE, BE IT RESOLVED BY THE SCHOOL BOARD OF THE BEEVILLE INDEPENDENT SCHOOL DISTRICT, SITTING AS THE GOVERNING BODY OF SAID INDEPENDENT SCHOOL DISTRICT, THAT:

Section 1: *THE RECITALS SET FORTH IN THIS RESOLUTION ARE TRUE AND CORRECT.*

Section 2: *THE BEEVILLE INDEPENDENT SCHOOL DISTRICT, BY AND THROUGH THE LAWFUL OFFICIAL ACTION OF THE GOVERNING BOARD, HEREBY ELIMINATES THE DISCOUNT ON EARLY PAYMENT OF DISTRICT TAXES, EFFECTIVE 2006 TAX YEAR, AS PROVIDED BY SECTION 31.05, TEXAS TAX CODE.*
