What is the CESA 2 Annual Convention?

About the CESA 2 Annual Convention

The CESA 2 Annual Delegate Convention is a meeting that occurs once yearly where school board members from each of the CESA 2 seventy-four member school districts are invited to attend. Delegates must attend in person, there is no virtual option. Check-in and hors d'oeuvres begin at 6:30 pm with the meeting to follow at 7:00 pm. The meeting will last approximately one hour and will not adjourn past 8:30 pm.

Purpose of the Annual Convention

Election of the CESA 2 Board of Control Members

The purpose of the Annual Convention is to elect members to the CESA 2 Board of Control. The Board of Control is an eleven-member board that typically meets on the third Tuesday of each month. These eleven board members are elected on a staggered election cycle. A school board delegate to the Annual Convention can be nominated, or can nominate themselves, to be considered for an open seat on the CESA 2 Board of Control. Details regarding open seats and the regional representation of seats are included in the meeting materials sent to you prior to the meeting.

Presentation

An agenda is emailed out prior to the meeting, which will contain information on our speaker for the evening. Each Annual Convention has a presentation regarding topics relevant to public education.

Networking

The Annual Convention is a great opportunity to network with other district's school board members.

Is this the only meeting I need to attend?

Yes, this is the only meeting you will need to attend at CESA 2 for the year. As the delegate representing your school district, you only need to attend the Annual Convention meeting which takes place in June. If you are elected to the CESA 2 Board of Control, you would need to attend additional meetings.

CESA 2 Board of Control Member Commitment if Elected

The CESA 2 Board of Control meets monthly on the third Tuesday of the month. Dinner is provided and arrives at 6:30 pm, with the meeting to follow and begin at 7:00 pm. The meetings provide updates on CESA 2 and our services to school districts. Board members are reimbursed for mileage to board meetings and may also participate in professional development opportunities on behalf of CESA 2.

Cluster I: Edgerton, Evansville, Oregon, Stoughton
