Together we will be promoting the safety of the children in Eagle Pass ISD.

Gatekeeper Systems agrees to supply the following equipment for evaluation purposes to Eagle Pass ISD:

- (2) SP322 Pod with 4 cameras- 2 LPR and 2 overview
- (2) 508HD DVR with 320 GB HD, GPS and Driver Alert Button
- (1) 500 series download kit

TERMS & CONDITIONS OF DEMO

1) DEMO TERMS-. The terms for this demo are to be 60 days from date of installation of equipment at agreed upon site, on vehicle of choice at Eagle Pass ISD, located at 1420 Eidson Road, Eagle Pass, TX 78852. In the event Eagle Pass ISD requires additional time to evaluate the equipment Eagle Pass ISD agrees to request an extension to the demonstration period in writing to Gatekeeper Systems, Inc. Gatekeeper will in turn respond to the request in writing indicating the length of the extension.

2) OWNERSHIP, LOCATION AND USE. The equipment remains the property of Gatekeeper Systems Inc. and under no circumstances shall title pass to Eagle Pass ISD during the Term of this Demo Contract, except as expressly provided herein. The equipment shall be located and used at Eagle Pass ISD place of business as set forth herein and may not be moved without the prior written consent of Gatekeeper Systems Inc. Eagle Pass ISD warrants that the equipment is being used for demonstration purposes and will be used for business and commercial purposes only.

3) EQUIPMENT TO REMAIN PERSONAL PROPERTY. Gatekeeper Systems and Eagle Pass ISD hereby agree that the equipment shall always remain and be deemed personal or movable property even though the equipment hereafter becomes attached to a motorized vehicle or affixed to realty. Eagle Pass ISD shall not, without the prior written consent of Gatekeeper Systems, make any alterations, additions or improvements to the equipment.
