Recited U.S. and Texas Pledges of Allegiance

The U.S. and Texas Pledges of Allegiance were provided by Dr. Ann Calahan.

I. <u>Call to Order and Announce Quorum Present</u>

President Calahan called the meeting to order and announced a quorum present.

II. Adoption of the 2018-2019 Budget

The motion was made by Mr. Parks and seconded by Dr. Dittfurth to adopt the budget for 2018-2019 including the General Operating Fund, Debt Service, and Child Nutrition. A copy of the 2018-2019 budget is attached hereto and shall become an official part of these minutes.

All members voted in favor of the motion. The motion carried.

III. Adoption of the 2018-2019 Tax Rate

The motion was made by Dr. Dittfurth and seconded by Mrs. Evans that the property tax rate be increased by the adoption of a tax rate of \$1.3429, which is effectively a 13.34 percent increase in the tax rate. A copy of the "Ordinance to Set Tax Rate" is attached hereto and shall become an official part of these minutes.

All members voted in favor of the motion. The motion carried.

IV. Approval of final 2017-2018 Budget Amendments

The motion was made by Mr. Osman and seconded by Dr. Barberee to approve the final 2017-2018 Budget Amendments as presented in Boardbook and recommended by Ms. Hummel. A copy of these amendments is attached hereto and shall become an official part of these minutes.

All members voted in favor of the motion. The motion carried.

V. Approval of temporary secured vestibule at Stephenville High School

The motion was made by Mr. Osman and seconded by Mrs. Evans to provide a temporary secured vestibule at Stephenville High School for the approximate cost of \$15,000.

All members voted in favor of the motion. The motion carried.

VI. Approval to provide high school/junior high students with keyboards

The motion was made by Mr. Osman that we pay for the keyboards. Mr. Osman withdrew the motion.

The motion was made by Mr. Parks and seconded by Dr. Dittfurth to allow Mr. Shelby Womack to handle the issuing of existing keyboards to the students that need them.

All members voted in favor of the motion. The motion carried.

VII. <u>Action-Item: Ear-marking an additional \$250,000 for security into the 2018-2019</u> <u>budget</u>
