I. The meeting was called to order by Superintendent Bente at 3:45 p.m.

II. Moved by Susen, seconded by Jurrens, to approve the agenda. The motion passed unanimously, 6-0.

III. Review of Policies

A. Moved by Moore, seconded by Susen, to approve sending Policy 301: School District Administration to the school board with no changes. The motion passed unanimously, 6-0.

B. Moved by Jurrens, seconded by Molitor, to approve sending Policy 302: Superintendent to the school board with no changes. The motion passed unanimously, 6-0.

C. Moved by Susen, seconded by Bente, to approve sending Policy 303: Superintendent Selection to the school board with no changes. The motion passed unanimously, 6-0.

D. Moved by Jurrens, seconded by Fashant, to approve sending Policy 304: Superintendent Contract, Duties & Evaluation to the school board with no changes. The motion passed unanimously, 7-0.

E. Moved by Susen, seconded by Jurrens, to approve sending Policy 305: Policy Implementation to the school board with no changes. The motion passed unanimously, 7-0.

IV. Revision of Policies

A. Moved by Fashant, seconded by Jurrens, to approve sending revisions to Policy 306: Administrator Code of Ethics to the school board. The motion passed after discussion, 6-1 (Bente, Steeves, Fashant, Jurrens, Molitor, and Susen voting in favor and Moore voting against).

B. Moved by Molitor, seconded by Fashant, to approve sending revisions to Policy 606: Textbooks and Instructional Materials to the school board. The motion passed unanimously, 7-0.

- Description: MSBA: Adds Art. V paragraph D (which quotes 20 USC 1232h(a))

C. Moved by Susen, seconded by Jurrens, to approve sending revisions to Policy 712: Video Surveillance Other Than on Buses to the school board. The motion passed unanimously, 7-0.

- Description: MSBA: Changes 'surveillance' to 'recording' per MSBA's attorneys' recommendation; clarifies video recording rule in Art.II.A.3

D. Moved by Fashant, seconded by Molitor, to approve sending revisions to Policy 722: Public Data and Data Subject Requests to the school board. The motion passed unanimously, 7-0.
