Adjunct faculty member(s) shall direct the activities and participation of students of the school district in sponsored and approved activities as designated from time to time by adjunct faculty member(s), for which notice shall be given to District administrative personnel. Adjunct faculty member's(s') activities and participation with students of the District are directed, supervised, and controlled by and through supervisory personnel of Texas AgriLife Extension Service,

pursuant to the supervisory authority of the District 1 Extension Administrator. Adjunct faculty member(s) is/are not the employee of District, and the District does not, nor shall not, supervise, direct or control the activities and or participation of such Potter County Extension Agent(s) who has/have been herein designated as an adjunct faculty member(s).

This appointment is made by District by and through the Board of Trustees of District for the benefit of allowing voluntary student participation in programs conducted by Texas AgriLife Extension Service in recognition of the educational benefits arising from such participation and activities and/or directed by Texas AgriLife Extension Service. This appointment is made in accordance with the provisions of Section 129.21(k)(1) of the Texas Administrative Code authorizing the school to deem such participating students in attendance for foundation and school program purposes.

This appointment of the Potter County Extension Agent(s) (employees of Texas AgriLife Extension Service) is/are not intended, nor shall be construed, as a waiver of any claim or defense of sovereign or governmental immunity from liability now possessed by District or any of its employees, agents, officers and/or board members in the performance of governmental functions.
