# B. Legislative Report

Supt. O'Neill reported the district has applied for the waiver for three additional forgiven days. A decision regarding the last day of school has not been made at this time. House Bill 4206 regarding snow day forgiveness is in committee and may influence the end of the school year. Supt. O'Neill will be in Lansing tomorrow to meet with legislators. There is discussion in the legislature about the possible elimination of the WorkKeys assessment to save funds.

Governor Whitmer's budget recognizes education and she proposes all students receive the same funding; not dependent on geographic location. Possible \$507 million increase to education under her proposed budget.
