**SUBJECT** Lobbying Proposal – Letter of Interest

Thank you for the opportunity to submit a proposal for lobbying services for Aitkin Public Schools, ISD#1. We believe that our experience in helping public schools secure capital project funding, breaking through bureaucratic logjams, and establishing new revenue streams for our school clients brings the creativity and spark that coud assist Aitkin Public Schools to successfully complete your facility plans and advance their importance for your voters.

# **Proposal**

The Costin Group will work under the direction of the Superintendent and School Board of the Aitkin Public Schools to secure funding for its developing plan for new school facitlities. We will help develop the tactics and strategies for successfully receiving outside fundin for the project and advise on working with the city and school to present a compelling plan to public policy makers.

The Costin Group has, over the years, established a proud record of serving public education through advocacy for our clients. We were the key drafters of the new Iron Range Cooperative Funding program several years ago.
