# Equitable Access to Excellent Teachers

Experienced, effective, in-field teachers – **86% of ISD 881 teachers (61/71)**

Inexperienced teachers – **14% (10/71)**

- An inexperienced teacher is defined as a licensed teacher who has been employed for three or less years.

Out-of-field teachers – **4% (3/71)**

No gaps have been identified in regard to equitable access of teachers for low-income students, student of color, or American Indian students.

The district's goal is to provide every student with an effective teacher who is appropriately licensed and has a passion for teaching, excellent interpersonal skills, a solid work ethic, and excellent classroom management and instructional skills.

# All Students Ready for Kindergarten

---

At least 50% of the Maple Lake Public School kindergarten students who attend the Wee Irish Preschool program will be at grade level during the fall testing window during the 2023-2024 school year.

- **Goal met:** 77% of kindergarten students were at benchmark during our fall math testing window.

- **Goal met:** 56% of kindergarten students were at benchmark during our fall reading testing window.

# Reading Act

---

Continuing to implement the 5 components of Reading Instruction and a Balanced Literacy approach into our core teaching in grades PreK-Grade 3

FastBridge testing to identify student growth

Achievement results disaggregated to identify students who require core instruction plus additional interventions through Title I, Reading Recovery, ADSIS, etc.



# All Students in Third Grade Achieving Grade Level Literacy

---

The percent of all 3rd grade students enrolled in Maple Lake Elementary School on October 1, 2023 who are proficient in the reading accountability tests (MCA and MTAS) will increase from to 47.1% to 50.1% in 2023.

- **3<sup>rd</sup> grade students were 53.7% proficiency on the MCA Reading Assessment they did meet the goal of 50.1% during the 2023 school year.**

## Fall 2024

Grade 2: 53% of enrolled 2<sup>nd</sup> graders are proficient on the FastBridge Reading Assessment

Grade 3: 61% of enrolled 3<sup>rd</sup> graders are proficient on the FastBridge Reading Assessment

MLE 2-6: 64% of enrolled students are proficient on the FastBridge Reading Assessment

# Close Identified Achievement Gaps in the District

---

The proficiency gap between all students and the special education students enrolled in Maple Lake Public Schools on October 1, 2023 who are proficient in the reading accountability tests (MCA and MTAS) will out perform the state average by 5% in 2023.

- **Goal met: 31.5% proficient** **State Average: 25.5%**

The proficiency gap between all students and the free & reduced students enrolled in Maple Lake Public Schools on October 1, 2023 who are proficient in the reading accountability tests (MCA and MTAS) will out perform the state average by 5% in 2023.

- **Goal met: 42.9% proficient** **State Average: 33.4%**

The proficiency gap between all students and the special education students enrolled in Maple Lake Public Schools on October 1, 2023 who are proficient in the math accountability tests (MCA and MTAS) will out perform the state average by 5% in 2023.

- **Goal met: 36.2% proficient** **State Average: 24.7%**

The proficiency gap between all students and the free & reduced students enrolled in Maple Lake Public Schools on October 1, 2023 who are proficient in the math accountability tests (MCA and MTAS) will out perform the state average by 5% in 2023.

- **Goal met: 46.2% proficient** **State Average: 27.0%**

# All Students Attaining Career and College Readiness before Graduating from High School

---

Maple Lake High School will have 100% of its students enrolled in 9th grade Civics courses during the third quarter complete a Career Investigation Unit and course plan, which includes a Personal Learning Plan.

- **Goal met: 100% participation**

The 80% of the Maple Lake High School juniors will take the ACT/PSAT.

- **Goal not met: 72% took the tests.**

Personal Learning Plans will be reviewed annually by 100% of the students enrolled in grades 10 and 11 at Maple Lake High School.

- **Goal met: 100% reviewed**

Percentage of students to earning at least one year of college credit after graduation. **57% of Maple Lake Seniors (23-24) earned at least one college credit.**

- **33% students enrolled in a 4 year College – 23% students enrolled in a 2 year college – 10% students were accepted into apprenticeship programs – 5% student joined the military**

---

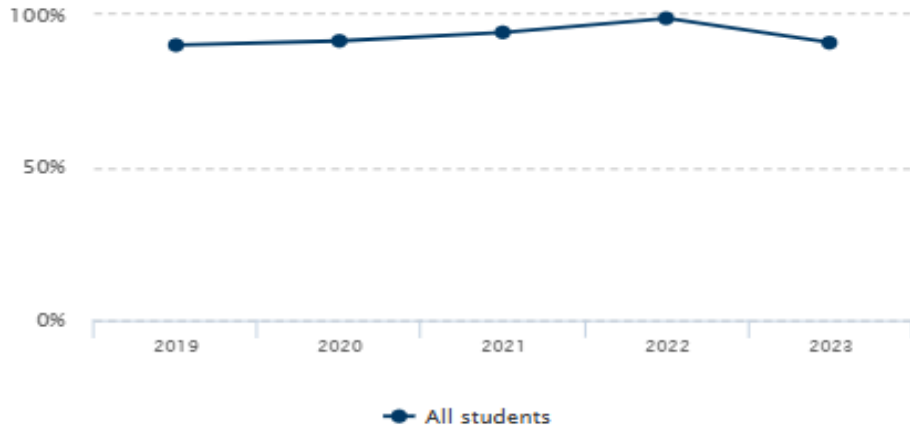
At least 95% of Maple Lake High School seniors will graduate in four years in 2023.

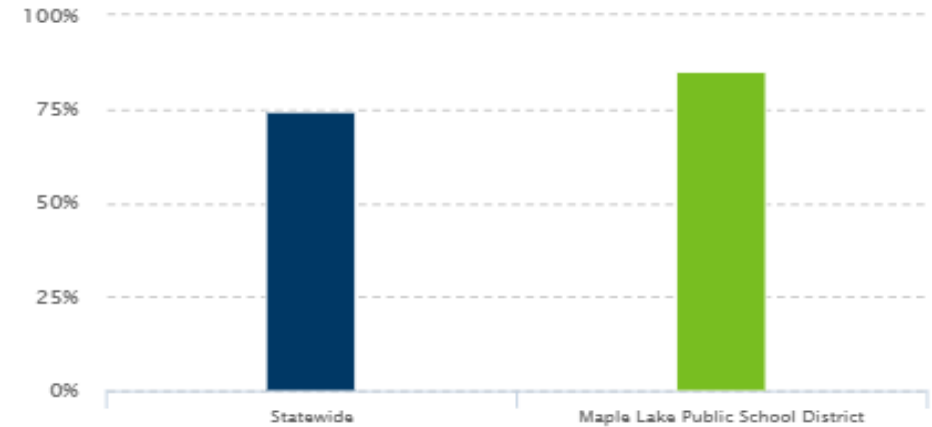
