Call to Order

In the absence of Budget Committee Chairman, Greg Barron, Board Chairman Barney Lindsay called the budget committee meeting to order at 7:00 pm; a quorum was established; and the pledge of allegiance was recited. Mark Burrows acknowledged that a quorum was present.

3. Establish Meeting Procedures

Chairman Currin asked Mr. Burrows what the plan was for the meeting procedures and Mr. Burrows responded that it would be the same as prior years. The meeting procedures will include an overview of the budget message and a brief overview of the budget document with any questions or concerns from the Budget Committee or Board being addressed.

4. Budget Message & Overview of Budget Document

Mr. Burrows discussed the overall budget for 2011-12 and was pleased to announce that unlike other districts MCSD is in a decent financial position for the current school year due to the federal stimulus money. While many schools are making program cuts and teacher reductions, MCSD has not had to make those cuts. He also stated that in the years that follow these monies will go away and the new biennium will hopefully bring additional revenues to the school district. The funds have stabilized in the current year and we can expect funding at the \$5.6B level with a \$100m increase based on criteria that will be established at a later time with the legislature (MCSD's portion is approximately \$400k). Mr. Burrows also stated that it will be very important for the county to pass the school fund level again in 2012 as the current levy is completed.

Mr. Fletcher gave a brief overview of the budget package outlining the revenues and expenses by the different cost codes. He also gave a brief description of where the money was budgeted – either at the district level or the individual school level.

5. Questions from the Budget Committee

Ms. Currin asked if the facilities were funded adequately. Mr. Burrows responded that he felt that the school district continues to maintain each of the schools well, and that the bonds in the past have helped with the significant projects such as the Riverside High School HVAC retrofit.

The chairman also asked if the district vehicles were adequate and Mr. Burrows stated that this was one area that Mr. Dirksen will have to make some investments in the current year. Mr. Dirksen believes the district will continue to drive the vehicles that they have until one can not be repaired and then it will be replaced.
