# **BOARD OF EDUCATION SPECIAL MEETING**

1. Call to order by Chair Wilson at 7:16 p.m.

### 2. Public Comment

Cheryl Thibeault stated that she has questions about the budget that she will send to us prior to the presentation of the Board of Education budget to the Board of Finance.

## 3. **2019-2020 General Fund Budget Approval** – Action Item

#### **Discussion:**

Commissioner Caggiano is looking for savings by using e-books. He said he has questions about teacher salary increases. We have been underfunding special education. He is nervous about going forward with this kind of increase.

Commissioner Vibert believes that it is important for our board to educate the public about what education is going to cost.

Commissioner Grabowski agrees this is a large request, but it is our job to tell the Board of Finance what we need. We may need to make cuts.

Commissioner Wilson stated that he has had conversations with members of the Board of Finance and City Council. They understand that we have to ask for what we need. If we say that we value our students and what they need, we have to request that.

Commissioner Giantonio stated there is agreement on the magnitude of this budget. When we have another 20 students enter who need special services, we need to meet those needs. If we believe in educating all children then this is what we have to do.

Commissioner Dube stated the size of the request is a lot. I'm in schools a lot and I see the need. I wonder about the long run. I'm a planner. I have a five year and ten year plan. We need to have a conversation about tough decisions including redistricting.

On a motion by Karen Vibert, seconded by Karen Hintz, the Superintendent's Budget totaling \$119,998,531 was adopted by the Board of Education to be forwarded to the Board of Finance for consideration, with the following votes: J. Caggiano "I do not support the budget", J. Dube, K. Giantonio, J. Grabowski, K. Hintz, K. Vibert, C. Wilson "I do support the budget".
