Angela Leal of the Westside Business Association shared the following:

"The Westside Business Association now in it's 35th year has a long history of promoting economic and educational development and the cultural history of Corpus Christi with emphasis on the Westside. We stood before you last month and petitioned to delay negotiations for six months and this Board accepted the petition, and instead accelerated actions to finalize the Spohn deal. Throughout the years, the Westside Business Association has succeeded in fulfilling its purpose and ha continued to surpass its commitment to help improve the Westside community of Corpus Christi. Since 1979, when the Westside Business Association formed to address concerns that the construction of the Crosstown Expressway would by-pass the businesses located in the Westside of Corpus Christi and through their efforts that resulted in having the Agnes/Laredo exit created and success in securing \$8.9M from the state of Texas for a crossover to be build. To-today, WBA stands with other community organizations and concerned citizens in coalition to petition and to push back against the Nueces County Commissioners and the Hospital District's decision to accept the Christus Spohn plan to demolish Memorial Hospital."
