On November 13, 2012 at 1:00 p.m., bids were opened and read for Snow Plowing Services. The services requested are:

- Bid Package #1: One-year contract to plow the parking lots only at Fabyan and Mill Creek Elementary Schools.
- Bid Package #2: One-year contract to plow and salt the parking lots for Geneva Middle Schools North and South
- Alternate to Bid Package #2: One-year contract to plow and salt walkways for Geneva Middle Schools North and South.

Six bid packets were issued but only four contractors submitted bids for the opening. One of the bids submitted was eliminated from consideration as all required documentation was not included in the packet.

Those contractors submitting bids were:

- Great Lakes Snow Systems, Inc., Elgin, IL
- BLP Construction, Sycamore, IL
- LawnBoyz Landscaping, Batavia, IL
- Bur Oak Group, Inc., Maple Park, IL – bid eliminated due to lack of documentation
