### ITINERARY:

To ensure adequate driver preparation, we require a detailed finalized itinerary listing all stops with complete addresses and anticipated timing at least 21 days prior to departure. Gratuity should be paid in check or cash directly to coach operator or escort. By request, we can add gratuity on to charter total and will be passed in full to the coach operator or escort for your charter.

### EQUIPMENT:

Teton Stage Lines maintains a fleet of safe, modern motorcoaches. In the unlikely event of a mechanical problem, delays due to weather or traffic conditions, or other causes beyond Teton Stage Lines control, Teton Stage Lines reserves the right to take whatever precautions deemed necessary to ensure the safe completion of your trip.

### LIABILITY:
