3. RECOGNITION, AWARDS, PRESENTATIONS, PUBLIC HEARINGS

3.1 Global Read Aloud (HSS & WAS)

Staff and students from Harrison Street Elementary School and Western Avenue Elementary School shared with the Board what they have been learning while blogging through global read aloud. Third grade students from both elementaries are learning the do's and don'ts of blogging, such as, never giving out personal information, because it can be very dangerous and not using mean words because it could hurt someone's feelings. Blogging allows students to connect with other students from other locations. Global read aloud connects with the District's vision by challenging our students to be self-directed, lifelong learners; effective communicators; complex, creative and adaptive

thinkers; and collaborative and productive citizens.

3.2 Student Services Presentation – Anne Giarrante

Ms. Giarrante and Mrs. Stephanie Martin shared with the Board updates on the continuum of services offered by our district.

The Alternative Learning Opportunities Program (ALOP) currently has 22 students enrolled. There are more females than males, and most of the students are seniors. Students in this program have to be at-risk for failure. They can have a 504 Plan, Individualized Education Plan (IEP) or be in regular education. The ALOP program currently consists of math, English, science, social studies and electives. This is a blended program with both technology and direct instruction. Going forward with this program, the district would like to write their own ALOP grant, work independently of the Mid-Valley Special Education Cooperative, utilize reimbursement for additional services to support students, and collaborate with outside agencies to provide targeted interventions to support students.

In the Functional Academic Skills Training program at the middle school level, students receive instruction from a special education teacher outside of the regular education environment for four periods a day. Students also receive instruction within the regular education classroom with support for four periods of the day. Moving forward, the district would like to enhance the program by providing students the opportunity to be instructed by a special education teacher in the content areas of science and social studies, add a vocational component to the program, and provide students enhanced opportunities related to independent living skills.

The Geneva Early Learning Program (GELP) currently has 39 students enrolled. Enrollment for the 2018-2019 school year is open. The special education program currently has 38 students enrolled. Most new students have social/emotional and/or behavior concerns. Of the current students, several may be dismissed this year due to increased performance. During the recent parent conferences, we received great feedback on the program. This year, the program has been able to participate in a Preschool Fair, the GenOvation Forum, STEAM Days, collaborate with Geneva High School Child Development class, and work to create a PTO for the program.
