The Board of Trustees of the Eagle Pass Independent School District held a Special Board Meeting on August 21, 2018, at 5:30 PM at the District Service Center Board Room, 1420 Eidson Road, Eagle Pass, TX 78852.

I. MEETING CALLED TO ORDER: Board President Lupita Fuentes called the meeting to order at 5:46 PM.

Ismael Mijares, Deputy Superintendent for Business & Finance, addressed the Board and Superintendent and initiated the presentation of the 1st & 2nd Budget Workshop. Mr. Mijares reviews the four District Funds categories (General Funds, Special Revenue Fund, Debt Services Fund, and the Capital Projects Fund) All Texas school districts use the same method to prepare their budgets. Every fund has its own revenues, expenditures and its own balances. Most of the money comes from the State. The General Fund is used to account for all financial transactions except for those required to be accounted for in another fund. The GF maintains 15 sub-funds the Special Revenues Fund maintain 3 sub-funds, Debt Services Funds maintains 1 sub-funds and the Capital Projects Funds maintains 1 sub-funds.

TEA requires districts to post their budget (current and proposed) on their district website. Today's proposed budget will be taken to the Board in August for approval. Mr. Mijares reviews the M & O subsidized funds (funds that do not generate enough money) to cover expenses. The subsidized programs are Athletics, Transportation, Special Ed., Food Service, State Vocational, State Bilingual, G/T and Mama Patrol. Also reviewed were the TRE and Tax Rate. The Proposed Tax Rate for 2018-2019 is 1.26. Today the only approval is to allow the publishing of this information in the newspaper as required. The Tax Rate for consideration to approve will be in another agenda along with a Public Hearing. The IFA State Aid Report was also reviewed. Mr. Mijares reviews the salary increase and the local step, which is not mandated by the state and the board approves the allocation of funds for the local step. Mr. Mijares confirms that the local step is only for professionals in only four (4) categories as follows: RN's, Counselors, Librarians and Teachers. Lastly, the

health insurance will continue the same as explained by Mr. Mijares. Board Members questions and concerns were addressed.

- I. MEETING CALLED TO ORDER: Board President Lupita Fuentes called the meeting to order at 5:39 PM and also includes the 3rd Budget Workshop.
- **II. PLEDGE OF ALLEGIANCE:** Superintendent Gilberto Gonzalez led the Pledge of Allegiance.
- III. PUBLIC HEARING TO DISCUSS THE 2018-2019 OFFICIAL BUDGET AND POSPOSED TAX RATE. NO ONE SIGNED UP FOR THE PUBLIC HEARING. PUBLIC HEARING CLOSED @ 5:40 PM.

NOTE: Board President allowed the Citizen's Communication/Recognitions to take place before the 3rd Budget Workshop.

IV. 3rd BUDGET WORKSHOP:

- 1. Review Estimated M & O Fund Balance. Deputy Superintendent for Business & Finance Mr. Ismael Mijares, briefly reviewed the Estimated M & O Fund Balance which was previously reviewed at the last budget workshop on July 31, 2018. The information has been updated, it is the same information provided, once the salary increases were added, which was approved at the last meeting. Looking into having a \$17.2 million Fund Balance. The Budget for next year has been completed to its entirety we do not have a deficit or a surplus. The Audit Document will be submitted to TEA as required. There is a minor change from last year under Public Notices Funds. The district needs to show how much funds are being used for Legal Notifications. This completes the Workshop. There are no questions from the Board.
- V. CITIZEN'S COMMUNICATION/ RECOGNITIONS: Mr. Edgar Juarez and Mrs. Anna Diaz, Mighty Eagle Band Representatives addressed the Board of Trustees and Superintendent in reference to the need of a bigger facility for the high school band, Five years ago the Band

Booster started a journey and requested a facility that would accommodate the band as it has tripled to over 250 band members. The five-year journey has come and they would like to know where they stand in regarding their request. The Band Booster has supported this Board when asked for their support and stepped up for the Board, The Band Booster sees everything the board has done for athletics, and teacher raises, which a great, but now they want the Board to support them and step up for the Mighty Eagle Band students. Students and equipment overfills the band hall when weather is not in favor, maintenance is lacking as electrical wires are exposed. Parent participation is tremendous, and feels that the students should have a better place to practice and store their equipment. The Band Booster is requesting a bigger facility and not just adding a wing to the facility. Board President Fuentes and Trustee Alvarez advised they are listening and are looking and talking about doing the best thing. Mr. Juarez & Mrs. Diaz thanked the Board for their support. Board President and Trustees support the interest and have addressed it to the Superintendent who has been working on this concern.

- 4. Delinquent Collection Activities for April June 2018. Ms. Sonia Gonzalez, Attorney, Linebarger Attorney at Law, addressed the Board and Superintendent and reviewed the Delinquent Collection Activities Report findings for April – June 2018. Board Members Alvarez and Bowles commended the law firm for its work.
- 5. Report on the 2018 Certified Appraisal Roll from the Maverick County Appraisal District. Deputy Superintendent Ismael Mijares reviewed the report and stated the Appraisal District has provided the report on the 2018 Certified Values and it indicates a \$2.4 values and some new properties at \$37 million, almost the same amount as last year... the growth has been consistent in our county. Trustee comment- it is the Appraisal District Board that raises the property value and not the School District Board or any other Taxing Entity. It is very important that the Superintendents Association contact our State Representatives and look into the matter to see what could be done. Eagle Pass has very unfair distributions of money in the state where the wealthy districts receive a lot more money than a poor district. It has been determined by the Texas Supreme Court that what is being done is wrong. Why is it that we don't do anything about it? Let's get serious and get this thing corrected. People that are poor need the help from the state... and we're not getting it and our State Representative needs to understand that.
- 6. Report on the Certification of the Estimated 2017/2018 Excess Debt Collections for the EPISD Interest and Sinking Fund. Deputy Superintendent Ismael Mijares reviewed the report on the Certification of the Estimated 2017/2018. Excess Debt Collections for the Interest & Sinking Funds. 100% on the I & S Tax Rate (Roll back calculation) and there is 0 amount of excess collections which is very good.

- 7. Review and discuss the 2018 Rollback Tax Rate Worksheet. Deputy Superintendent Ismael Mijares reviewed the 2018 Rollback Tax Rate Worksheet to the Board and Superintendent. The Rollback Tax Rate Worksheet includes two calculations, which are the Effective Tax Rate and the Rollback, which is required to report to the Board.
- 8. **Presentation on the 2018-2019 Student/Parent Handbook.** Deputy Superintendent for Curriculum & Instruction Samuel Mijares briefly reviewed the handbook and stated it is brought to the Board on a yearly basis and any modifications and/or changes come from the TASB layout. The Board has been provided with 18 updates and after todays presentation to the Board it will be posted in the district website.
- 9. Presentation of the Texas Department of Agriculture School Nutrition Program and Food Service Department. Food Service Director Mario Garcia provided a presentation of the Texas Department of Agriculture School Nutrition Program to the Board and Superintendent. The presentation included the following: TDASNP Administrative Review, and Procurement Audit and the Food Service Department changes and cafeteria innovations. Comment: Board Member Martinez commends the Food Service Department Director, staff, and all those involved that have made this come to the right direction. The Board has been waiting for this for a very long time.
