9. DISCUSSION/PRESENTATION

9.A. BOE Presentations 2025-26

The board recommended the following for 2025 BOE presentations: Updates from LBES and LBMS mid-year. Enjoyed the video presentations. With new curriculum and initiatives, it would be helpful to get updates on enrichment, 3rd grade ELA, iPad roll out. True North updates. Updates on LBMS Math Applications roll out. Financial terminology from Jay Kahn, a few at each meeting. Presentation from Austin on Safety and Security, especially around the new door locks and staff compliance with keeping doors closed. Student behavior midway check-in, ie: percentage and frequency of students being sent to the office. Discussion about recognition of teachers and students to be added to a future agenda. A request for the board to complete Ruler training was made as well.

9.B. Student Behavior and Discipline Update - Kellie Bae, Nate Blackmer Principals Kellie Bae and Nate Blackmer gave a detailed presentation on student behavior and discipline. Staff are trained through Safe and Civil Schools to ensure school climate and safety along with staff collaboration and consistency. Proactive behavior approaches are introduced to new staff at the time of onboarding; Principals Bae and Blackmer work throughout the year with all staff. Student discipline is grounded in classroom expectations, our teams work together on how to support students. Our goal is for all students to be in class and highly engaged. When an issue arrives, partnering with parents/guardians is an ongoing part of our discipline practice. We work with Foundations Cohorts and Ruler Programs to ensure consistent and all-encompassing student discipline. Teachers have been coached to ensure behavior reporting is consistent. Positive reinforcement is an ongoing practice. Examples are in the board packet. Examples of behavior levels and follow-up can also be found in detail in the board packet. Reinforcement of expectations can be found through the Student Handbook, parent informational nights, parent/teacher conferences, and principal updates.

9.C. Technology Update - Kevin Kolcz

Kevin Kolcz gave a thorough update on technology. A big shift this year that came out of the Anxious Generation book club and the reconvened Technology Committee was removing YouTube from all devices, students and staff. We also eliminated 20 subscriptions and consolidated others. We've installed new firewalls, and have created AI staff guidelines. Each building's internet will be independently operated, with back up for both buildings as well. We have been working closely with our two big subscriptions of PowerSchool and Schoology, which currently operate with a 7% annual increase and have negotiated a lower price increase over 5 years. We are saving a substantial amount of money by moving to Sentinel as our full-time online monitoring partner. Kevin and the tech team have spent time training teachers on the new iPads, including Apple Classroom, which is a great platform and free of cost to us. Kevin is working on additional coaching throughout the year, especially for new teachers. We are looking to decrease the various individual classroom social media accounts and move to SeeSaw, which is district provided and supported. Next school year we will introduce a parent

tech night, including information on Schoology and Screen Guide to help parents monitor athome usage. The Tech Summary can be found in the board packet.

9.E. Tentative Budget - Jay Kahn

Jay Kahn reported that this is the first draft of the 2025-26 budget that is presented annually in June. Our debt service is fairly flat, and we are balanced. There is zero net change in the Operating Fund Budget. The tax levy is going up 3.3%. 1.9% increase in operating funds, 1.6% increase in total expenditures. Details can be found in the board packet.
