Each individual granted remote access privileges pursuant to this policy must adhere to the following standards and regulations:

- ()A. his/her device computer/device must have active on it, at the minimum, the an anti-virus program with the latest updates from the manufacturers oftware specified in the District's standards for remote access and connection
- (x the individual may only access the Nnetwork using his/her assigned B. user name and password

The individual **is prohibited from** must not allowing other persons, including **friends and** family members, to use his/her user name and password to log into the **Nn**etwork. The user may not go beyond his/her authorized access.

- ()C. his/her device may not be connected to any other network at the same time s/he is connected to the N**n**etwork, with the exception of personal networks that are under the complete control of the user
- D. the individual may not access non-District e-mail accounts (e.g. Hotmail, Gmail, Yahoo, AOL, and the like) or other external resources while connected to the Network
- ()E. his/her device may not, at any time while the individual is using remote access to connect to the Nnetwork, be reconfigured for the purpose of connecting to another (an additional) networksplit tunneling or dual homing
