Background Information

The attached financial reports represent the preliminary results of operations through May 31, 2025.

- For the General Fund, revenues were 79% last year compared to 76% this year. Expenditures were 79% last year compared to 77% this year.
- For the Child Nutrition Fund, revenues were 83% last year compared to 74% this year. Expenditures were 92% last year compared to 71% this year.
- For the Debt Service Fund, revenues were 95% last year compared to 91% this year. Expenditures were 98% last year compared to 85% this year.
