Owner to carry necessary insurance on above work. JBI to carry Workmen's Compensation & Public Liability Insurance. JBI is not responsible for landscaping, damage to plumbing or electrical, cracks in slabs, floor or walls. Price is subject to change, with customer's approval, if the hollow under slab is greater than anticipated.

LIMITED GUARANTEE: On concrete over 10 years old, JBI will re-pump once, in a twelve month period, if necessary, any areas that have resettled more than a 1/2". A re-pump requires drilling new holes. There will be a \$50.00 service fee for the truck to return for a re-pump or any other reason. This guarantee does not include patches applied to or placed between the slabs. This guarantee is void if the customer does not seal all cracks and joints on the slabs or maintain BACKFILL along the slabs involved or if resettling occurs as a result of flooding or other acts of God. There is no warranty on caulking due to winter ground movement, caulking is a routine maintenance issue. If the concrete cannot be mudjacked and must be replaced, it is the home owner's responsibility to replace it at current replacement cost. Replacement concrete will be 4,000 psi or greater. Pitting, popping, scaling, or cracking due to weather conditions or minor settling is not a warranty item. Due to equipment used in concrete removal and replacement, JBI is not responsible for damage to lawn and existing driveways. Home owner is responsible for top soil repair and re-seeding, unless specified in bid. On concrete replacement any unforeseen issues or added fill will be charged accordingly.
