Data Use Agreement

Scope: This data use agreement, entered into on [date listed below], is an agreement between The Policy & Research Group (PRG) and San Carlos Unified School District (SCUSD). The data will be used in a rigorous outcome evaluation of The Wisdom Project (Award #U411C110308), which is funded by The U.S. Department of Education under the Investing in Innovation Program and implemented at Baboquivari Unified School District. SCUSD will be the comparison school district for this evaluation.

<u>Data</u>: This agreement pertains to the following type of data: quantitative, individual student-level data, such as standardized test scores, graduation status, dropout status, and demographic characteristics and qualitative data such as interviews with key district stakeholders.

<u>Term</u>: Data collection will occur at least once per project year during the grant period, 2013 to 2016. Since the project ends on December 31, 2015, the final data collection will take place during 2016.

Stipend: SCUSD will receive an annual stipend of \$1000 per year, once all data for the year have been submitted to PRG.
