With intent to move forward, we will have engineered designs created based on the specifics of your field measurements and locations to one another. It is quite possible that common poles may be used between the baseball and softball fields which could reduce the projected cost. It is also possible that if allowed to move forward based on a "turnkey" purchase of our product with installation by a an experience Musco Installer that the projected cost could be reduced even more. We will be glad to get three contractors who are experienced sports lighting installers to bid their install costs to us and pass on the results of those bids to you through a Texas Buy Board, or Tips and Taps Cooperative Quote.

Budget Estimate Criteria

- Guaranteed light levels of 50 footcandles on the infield and 30 on the outfield for Baseball and Softball Diamonds and 50 footcandles on the Football Field, within +/- 10% per IESNA guidelines.
- Confirmation of voltage and phase prior to shipment
- Structural code and wind speed = 2006 IBC, 90 MPH
- Musco is a lighting manufacturer and not an electrical contractor. Installation estimates are based upon projects similar in scope.
- Getting electrical power to the site, coordination with the utility, and any power company fees are responsibility of the owner (if not currently available).
 - Standard soil conditions. Rock, bottomless, wet or unsuitable soil may require additional engineering, special installation methods and additional cost.

Please do note that the existing asphalt must be within tolerance (1/4" in 10 ft any given direction), it is not possible to determine if the asphalt is in good conditions without removing the existing surface and exposing the clean asphalt. It is to the owner's advantage that the new track installation is done over a good asphalt base, otherwise the school will not get back their investment.

The existing asphalt must support the weight of the construction equipment during the removal process and the installation of the synthetic surface. For the most cases the use of a box blade tractor (Case 570) is sufficient but there could be a need of a small motor grader for the removal of the existing surface, if the asphalt start to show any type of movement or pumping we will immediately stop and notify the owner, unless there is a geo-tech report with moister conditions, density test and compaction percentage, it is not possible to determine if the asphalt will hold, nor would it be fair to hold the contractor responsible for such event.

There are no visible indications that the asphalt would not hold, but we do need to proceed with caution at the beginning of the project.
