Early Learning Center

- At Mary Kay McNeill Early Learning Center, students were buzzing with excitement as they designed and built their very own leprechaun traps with their families! This hands-on activity sparked creativity, problem-solving, and teamwork as children used various materials to craft clever traps in hopes of catching a mischievous leprechaun. From colorful rainbows to tiny ladders and hidden doors, each trap is unique and filled with imagination. The anticipation grew as students eagerly awaited St. Patrick's Day, wondering if their traps would be clever enough to catch a leprechaun—or at least find some magical surprises left behind!
- With the sun shining brightly and a gentle breeze in the air, our preschoolers are embracing the joy of outdoor play. Laughter fills the playground as children run, climb, and explore, making the most of the beautiful weather. The warmer temperatures provided the perfect opportunity for hands-on learning, social interaction, and physical activity—key components of early childhood development. Days like these remind us of the importance of play in fostering curiosity, creativity, and a love for learning.

Taking on the roles of town council members, students put their knowledge into action through an immersive town simulation. They collaborated on how to allocate funds, planned infrastructure, government buildings, and housing, and created detailed town maps to showcase their vision for a thriving community.

- Beyond professional growth, Oakland staff also values camaraderie and school spirit. A spontaneous, unofficial spirit week added excitement to the school, with themed days like Flannel Day, Blackout Day, and Anything But a Cup Day. Students enjoyed the fun and surprises each day brought.

The lesson extended beyond reading comprehension, as students created advocacy posters and practiced articulating their rights, fostering a deeper understanding of civic engagement and the power of their voices.

- Mrs. Hehn's class embarked on an exciting adventure following the Iditarod! They eagerly tracked the race, learning about the challenging rerouting due to this year's unusual snow conditions. Students gained fascinating insights into the rigorous training mushers and their incredible dog teams undergo. Each day, the class buzzed with anticipation, using their wall chart to meticulously track distances, check-in times, and the thrilling progress of each musher, culminating in the exciting reveal of the ultimate champion!

AUGS

- The AUGS Drama Club successfully completed its spring play, Knights of the RAD Table, on March 14th and 15th. With over 30 cast and stage crew members, the production showcased the dedication and talent of our students. Directors Ms. Melissa Stetkus and Ms. Jo Clark led the group, while parents volunteered to assist with costumes and stage setup. The D117 Drama Department generously supported AUGS by providing stage props, and additional assistance came from our staff, custodial team, print shop, and administration. Since January, students committed themselves to rehearsals, perfecting their lines, enhancing their acting skills, and managing technical aspects such as lighting and sound. Their hard work and teamwork resulted in an outstanding performance, demonstrating the power of collaboration and creativity within our school community.
- AUGS celebrated its annual Pi Day with various engaging activities, including the memorization contest, a trivia contest where students solved math riddles throughout the week to unlock Pi facts, create a Pi chain of digits, and explore how Pi is used in circle calculations. This exciting event brought math to life while fostering school spirit and student engagement.

The appointment, employment, compensation, discipline, performance, or dismissal of specific employees, specific individuals who serve as independent contractors in a park, recreational, or educational setting, or specific volunteers of the public body or legal counsel for the public body, including hearing testimony on a complaint lodged against an employee, a specific individual who serves as an independent contractor in a park, recreational, or educational setting, or a volunteer of the public body or against legal counsel for the public body to determine its validity. However, a meeting to consider an increase in compensation to a specific employee of a public body that is subject to the Local Government Wage Increase Transparency Act may not be closed and shall be open to the public and posted and held in accordance with this Act. 5 ILCS 120/2(c)(1).
- b. The setting of a price for sale or lease of property owned by the District. 5 ILCS 120/2(c)(6).
- c. Security procedures, school building safety and security, and the use of personnel and equipment to respond to an actual, threatened, or a reasonably potential danger to the safety of employees, students, staff, the public, or public property. 5 ILCS 120/2(c)(8).
- d. Student disciplinary cases. 5 ILCS 120/2(c)(9).
- e. Litigation, when an action against, affecting or on behalf of the particular District has been filed and is pending before a court or administrative tribunal, or when the District finds that an action is probable or imminent, in which case the basis for the finding shall be recorded and entered into the closed meeting minutes. 5 ILCS 120/2(c)(11).
