



## RESOLUTION

**Whereas** it is within the role of the Board to designate names for facilities;

**Whereas** the District's Vision 2023 Mission Statement is "Fort Smith Public Schools, a premier district where innovation creates excellence, is dedicated to providing an equitable, challenging educational experience by engaging families and community partners as we prepare students to embrace their roles in our culturally diverse community and rapidly changing world";

**Whereas** it is central to the mission of the district that all students feel welcome at school;

**Whereas** Albert Pike Elementary School is named for a Confederate general;

**Whereas** Albert Pike joined a petition in 1858 to "expel all free blacks from the State of Arkansas";

**Whereas** Albert Pike wrote in 1868, "We mean that the white race, and that race alone, shall govern this country. It is the only one that is fit to govern, and it is the only one that shall";

**Whereas** Vision 2023 Parameter 2 states that, "We will honor relationships and treat all people with dignity and respect";

**Whereas** Vision 2023 Parameter 1 states that, "We will base decisions on what is best for students";

Now, therefore be it resolved that the Fort Smith Public Schools Board of Education indicates its intent to adopt a new name for Albert Pike Elementary School for the 2021-2022 school year and directs the Administration to organize a committee to develop and recommend to the Board for its consideration a renaming process that will include stakeholders from within the Albert Pike Elementary School community.
