Mades Johnstone Center Electrical Panel Replacement

As part of Mid Valley's Five Year Capital Improvement Plan, Mid Valley has bid the Mades Johnstone Center Electrical Panel Replacement project. A total of 1 bid was submitted for the electrical panel replacement project. The bid received for the improvement was below the estimated amount allocated in the Five-Year Capital Improvement Plan. Administration and our architects ATS&R recommend proceeding with the Mades Johnstone Center Electrical Panel Replacement project base bid (see attached recommendation and bid recap).

## Net Budget Impact:
