III. CONSIDER APPROVAL OF A BUDGET AMENDMENT FOR UPGRADE OF GISD WIRELESS NETWORK

Technology Director, Chris Rasile provided the board with the following information: Graham ISD is eligible for the E-Rate funds that will help update Graham ISD's wireless network across all campuses and facilities. The E-Rate funding program provides funding to K-12 schools to purchase hardware that increases their access to reliable, high-speed broadband internet and wifi. E-Rate will fund 80% of the total cost of the upgrade to Graham ISD's wireless infrastructure including a 5-year warranty, but requires the remaining 20% be funded by the District.

A motion by Dr. Brandon Bates, seconded by Jason Smith, carried 7 to 0 for the Approval of a Budget Amendment in the amount of \$97,055.00 to cover the district's portion of the cost of upgrading the GISD Wireless Network. The motion passed with
