## Background:

Adopting a levy on an annual basis is one of the major functions of the Board of Education. Revenues from local property taxes generate approximately 89% of all revenues for this school district, which is done through the levy process. On October 21, 2019, the tentative levy was presented to the Board of Education, as required by law at least 20 days prior to its adoption. Finally, the levy needs to be filed with the County Clerk's Office on or before the last Tuesday in December.

## Situation:

On Monday, December 2, 2019, a notice was published in the Daily Herald announcing a public hearing to be held at the District Office on December 16, 2019 for the purposes of adopting the 2019 tax levy. Levy amounts were determined based on projected expenditures for the 2020-2021 Budget. Revenues from the 2019 levy will be received in June and September, impacting two budget years. The district's levy request reflects an increase of 3.58%. When the County Clerk sends the final tax levy notice in May 2020, the budget for Fiscal Year 2020-2021 may be adjusted accordingly prior to approval in September 2020.

For your convenience I have attached the four legal documents that will need to be signed by the Board of Education's President and Secretary; 1.) Resolution Approving the Tax Levy, 2.) Certificate of Tax Levy (ISBE 50-02), 3.) Certificate Regarding Inapplicability of the Truth in Taxation Law 4.) The Secretary's Certificate for Approving the Resolution of Tax Levy.

# **Recommendation:**

That the Board of Education of Bloomingdale School District 13, DuPage County, Illinois, approve levies on the equalized assessed valuation of the taxable property of said school district for the year 2019 as described in the Resolution Approving 2019 Tax Levy as presented.

#### **RESOLUTION APPROVING 2019\_TAX LEVY**

WHEREAS, the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, has determined the amount of money that is necessary to be raised by taxation for the year 2019; and

WHEREAS, the Board of Education has heretofore adopted a Budget Resolution for the District for the fiscal year commencing July 1, 2019 and ending June 30, 2020; and

WHEREAS, the Board of Education disclosed at a public meeting its intention to adopt a levy; and

WHEREAS, the Board of Education provided notice of its intent to adopt a levy.

NOW, THEREFORE, BE IT AND IT IS HEREBY RESOLVED by the Board of Education of Bloomingdale School District No. 13, DuPage County, Illinois, as follows:

1. That there shall be and there is hereby levied by the Board the amounts set forth on Exhibit A attached hereto and made a part of this Resolution, which is the Certificate of Tax Levy for the year 2019.

2. That the Board President and Board Secretary are hereby authorized to execute the Certificate of Tax Levy and supporting forms and Certifications and the District Administration is hereby authorized and directed to file the Certificate of Tax Levy and all supporting forms and Certifications with the County Clerk of DuPage County, Illinois.
