I. Call Meeting to Order

V. New Business - Action Item

V.A. Consideration & Approval of 2023-2024 Budget

Motion by Trustee Hall to approve the 2023-2024 Budget, 2nd by Trustee Barton. Trustee Hall and Trustee Barton vote Aye. Trustee Reinbold, Vice Chair Brown and Chair Rutledge vote nay. Motion fails.

Chair Rutledge states that he wants further clarification on cash flows, accounts receivable, accounts payable and available cash and for it to be reviewed by Superintendent Durst. Will set up a meeting for the following week and then will approve it.

Trustee Hall asks for clarification from Steffie regarding sending the budget to the state, Steffie defers the question to Superintendent Durst. Superintendent Durst states that in his understanding there is no enforcement mechanism from the State regarding the budget being submitted on time, that the District can continue to operate without a budget but that it should be done as expeditiously as possible.

Trustee Hall states that it seems as if there were communications between some of the board regarding information that others were not privy to, she has concerns of collusion or conversations between three of the board members and that it constitutes as open meeting violations.
