On February 27, 2017, a fourth donation totaling \$55,200 was received from Mylan Company for EpiPens 2-Pak (Epinephrine) Auto-Injectors 0.3mg and EpiPenJr 2-Pax (Epinephrine) Auto-Injectors 0.15mg. These EpiPens 2-Pak are worth \$600.00 each and the district received a total of 47 boxes of pediatric Epipens and 47 boxes of adult Epipens for a total of 92 boxes. These Epi-pens will be distributed to all campuses to provide emergency care during a severe allergic reaction (Anaphylaxis) which can be life threatening.
