PART-TIME ADVOCATE

The Personnel Committee had previously approved the hiring of a part-time crime victim advocate in 2017. In 2020, Julie Jackson, the then part-time advocate, took on the newly formed full-time position of Crime Victim Navigator. The part time position was not refilled.

Since the abandonment of that position, the number of victim cases coming through the office has remained at a level that would still necessitate another part-time victim advocate. This necessity has been confirmed by the grant funders. It is at this time that we would ask for re-approval to fill that role.

This position is sustainable because we have the funding of a part-time position through the grant supplied by the Crime Victim's Commission in our current grant funding. Recently, we were visited by representatives from MDHHS, Division of Victim Services who showed us how we may move available funds within the grant budget to support this position without the need to ask for additional funding.

This position is necessary to assist in maintaining the excellent service for victims of crime in this county. Currently, we have one advocate who must cover three courts as well as constant contact with all victims outside of the courtroom. As it is impossible to be in three places at once, a second advocate would be invaluable to the office.

We are requesting permission to fill this position as soon as possible.
