Consider Approval of Renewal of Contract 2008.411 General Foods and Full Service Food Distribution

## Background:

On May 5, 2008, Contract 2008.411, General Foods and Full Service Food Distribution, was awarded by the Board of Trustees. This is the final renewal option for this three (3) year contract. Child Nutrition estimates \$7,500,000.00 for general foods, dairy and bread products needed to support the district with food and supplies. Therefore, it is the recommendation of the Purchasing Director and the Director of Child Nutrition that the subject contract be renewed for an estimated cost of \$7,500,000.00. This is the final renewal option for this three (3) year contract.
