On a motion by Mrs. Davis, seconded by Mr. Wheeler, the Board voted unanimously to approve the payment of the insurance premium as requested by Mrs. Murphree. The President of the Board declared the motion passed.

Mr. Prather entertained a motion to adjourn. Mr. Wheeler made a motion, seconded by Mrs. Davis, that the meeting be adjourned. The motion was adopted unanimously by all members present, and the meeting stood adjourned at 12:02 p.m.
