BOARD PRESIDENT REPORT:

Kathie Gautille reported that the NTAASB would like to hold a meeting in Coppell on September 19, 2007 and have former Lieutenant Governor Bill Ratliff as guest speaker to talk about the *Raise Your Hand Texas* campaign.

BOARD MEMBER REPORTS:

Cindy Warner has met with Senator Shapiro and Congressman Jackson about budgetary concerns regarding the amount of money funded per student.

Bennett Ratliff reported that a record number of grants totaling more than \$125,000 were awarded to the District by the Education Foundation.

Donna Carpenter, CHS, gave an overview of the Achieve Texas College and Career Redesign grant she submitted to TEA. Several grants in the amount of \$50,000 will be awarded to schools across Texas in August 2007.

Cindy Warner made a motion to accept the administration's recommendation of Karen Nix for a teaching position at Coppell High School for the 2007-2008 school year. Bennett Ratliff seconded the motion. The motion carried 5-1. (Kathie Gautille was opposed.)
