Enclosed is the **2025-26** edition of **The Interagency Agreement Regarding the Provision of Service Delivery & Transition for Young Children & Families** among community and local education agencies in Cuyahoga County, Ohio. This revision continues to incorporate the most recent Interdepartmental Agreement between the Ohio Department of Education and Ohio Department of Health, the Ohio Department of Health/Help Me Grow Rules, and the Operating Standards for Ohio's Schools Serving Children with Disabilities. This document fulfills your District's requirement for an Interagency Agreement as defined in Ohio Operating Standards for the Education of Children with Disabilities, and *Preschool children eligible for special education, 3301-51-11* both effective December 1, 2023. In addition, the 2025-26 Agreement functions as a resource for all agencies to ensure the accuracy of information shared with families of young children regarding screenings and referrals, evaluations, transitions, and services. The intent is that this agreement assists all team members in understanding the specific steps to serve young children and their families.
