I have reviewed the bids submitted. If the school district elects to award only the base bid, it is my recommendation that the contract for construction be awarded to Murphy & Sons, Inc. Murphy & Sons' base bid is in the amount of \$1,891,200.00. Please keep in mind, however, that there are the following nine (9) additive alternates for this project:

- Alternate Number 1: Furnish and install new HVAC equipment in Gymnasium 508 as
- Alternate Number 2: Furnish and install new lighting in Gymnasium 508 as shown.
- Alternate Number 3: Install a seamless insulated roof system on the Gym Wing (Roof-I).
- Alternate Number 4: Prepare and paint the exterior of the Gym Wing as shown with elastomeric coating.
- Alternate Number 5: Prepare and paint the interior of the North Wing Classrooms 104, 111, 114, 116, 120, 126, and 128.
- Alternate Number 6: Remove a section of the existing canopy at the Cafeteria Wing and replace with new aluminum canopy as shown.
- Alternate Number 7: Prepare and paint the exterior of the Cafeteria Wing as shown with elastomeric coating.

- Alternate Number 8: Prepare and paint interiors (as indicated on the drawings) with Sherwin Williams Paint Shield Microbicidal Interior Latex Paint in lieu of Sherwin Williams ProMar 200 Interior Latex Paint as indicated in Section 09910.
- Alternate Number 9: Prepare and paint the interior of the North Wing Classrooms 104, 111, 114, 116, 120, 126, and 128 with Sherwin Williams Paint Shield Microbicidal Interior Latex Paint in lieu of Sherwin Williams ProMar 200 as indicated in Section 09910.

The maximum amount of work to be performed at ECEC would include the Base Bid, as well as Alternates 1, 2, 3, 4, 6, 7, 8, and 9. If the school district would like to award the maximum amount of work, I recommend that the contract for construction be awarded to McCarty King Construction.
