The 24/25 District Operational budget as presented to the board on 6/11/24 was approved by PED on 6/30/24. A memo from PED was sent out in June raising the unit value for 24/25 from \$6,442.55 to \$6,553.75. The memo also states that PED will send out another memo in late July or August letting the district know when we can do a BAR for the SEG increase. The unit value increase multiplied by the program units used for the 24/25 SEG should bring in about \$2.2 million more in SEG funding to the district.
