The total attendance average for the Denton ISD for Cycle 4 is 95.05%. The lowest total attendance average is for PK 91.80 % followed by EE grade 92.64%; 12th grade is 92.93% (lowest secondary). The highest attendance averages are in the 5th grade, 96.17 followed by 4rd grade, 95.86%. The 5th grade has had the highest attendance percentage each grading cycle.

RF Summary Compliance Report

The Texas Education Agency (TEA) began Residential Facilities (RF) On-Site Monitoring visits in 2005-2006. The purpose of the visits was to complete a comprehensive evaluation of the effectiveness of the program for RF students and to determine the compliance with federal and state requirements. During the on-site visits, the review is conducted in accordance with the procedures in the Residential Facilities Monitoring Manual. Denton ISD was selected for an on-site visit in both 2005-2006 and in 2006-2007. As a result, the DISD was assigned a TEA Conservator. In April of 2010, TEA released the Conservator. In a letter to the superintendent on January 25, 2013, Denton ISD has met the "compliant" status for RF monitoring.
