The team is using the [IMET](#) (Instructional Materials Evaluation Tool) that was developed by Student Achievement Partners to guide the evaluation process. Our goal, for this 20-hour process, is to evaluate 4 math curriculum programs: [My Math](#), [Everyday Math-CCSS Edition](#), [Eureka Math](#), and [Math Trailblazers](#). Given that the process is moving faster than initially anticipated, we have decided to add the [Investigations](#) program to our review. These programs were chosen for review after conversations with our UIC partners, District 97 teacher leaders, and other national and local curriculum directors.
