Re:	JailTracker (sic) Software

The Corrections Division at the Sheriff's Office is in need of new inmate booking software and have been working with our current records management software (RMS) provider (CORE TECHNOLOGY) for options.

In or around 2012, the Sheriff's Office switched from LEMS to CORE to provide RMS for the Deputy and Corrections Divisions. This needed to be done because LEMS was going out of business. At the time, CORE only provided RMS for law enforcement agencies but had partnered with Justice Data Solutions to provide inmate software entitled "JAMIN."

For a few years, JAMIN worked adequately for the Corrections Division. In 2017, several reports needed to be pulled from JAMIN to assist the Jail Advisory Committee with much needed data. The data was available because of the booking questions that were asked of inmates, but the reports needed to run the reports were not available. When Justice Data Solutions was contacted to see if they could pull the reports, the Committee was informed that the reports could be generated for an additional cost. Because of the short timeline and because additional costs didn't want to be incurred for reports that should have been readily available, the Committee extracted as much data as possible. Some of the reports were adequate and others were difficult to convert.

Justice Data Solutions has been difficult to work with and slow to update its software to meet the current needs of the Corrections Division. It is for these reasons that it is necessary to move to a more modern jail records management software.

CORE has partnered with "JailTracker" Jail Management Software. Information on the software is attached to this memo for your review.

It has been a goal of the Sheriff's Office to go to a paperless jail RMS. This software will accomplish that goal.

The cost for the software is \$49,528.60. The cost is based on the maximum number of inmates that can be held in jail. Currently, that number is 69. If we wait to purchase the software until after we have moved into the new Sheriff's Office, that cost will increase significantly.

We have made arrangements with our current inmate phone provider (Combined Public Communications) to pay for the software. This will be made possible by extending our current contract with them. That contract is currently under review by the Prosecutor's Office.

It is my intention to host the software locally on a server to be located in the IT Department. That server needs to be purchased and can be done so because of the sale of two generators that were obtained from the federal 1033 program. The requirements for the server have been sent to IT for their review. I'm hoping to have the type and cost of that server available for the full Board of Commissioners meeting to be held at the end of the month as well as the final review of the inmate phone contract review from the Prosecutor's Office.




