Issue Summary:

In accordance with applicable Board policy, contracts and MOA's \$10,000 or greater require Board approval.

Background:

The North Slope Borough School District requires periodic maintenance of all heating, ventilation, air conditioning (HVAC), as well as yearly inspection and recertification of all fire detection and suppression systems.

The scope of services for this contract is to provide recertification of fire alarm systems, test kitchen hood system, test sprinkler system, dialer account renewal for 12 months for Meade River School, and Alak School. AFS will recertify the fire alarm system and renew the dialer account for 12 months in Kali School.

Length of Contract:

The length of contract is for one year commencing upon approval of this memo and execution of the MOA and terming as of June 30, 2022.
