Domestic Violence, Harassment, Sexual Assault, <u>Bias,</u> or Stalking Leave <u>(Safe Leave)</u>

Definitions

- 1. "Covered employer" means an employer who employs six or more individuals in the state of Oregon for each working day through each of 20 or more calendar workweeks in the year in which the eligible employee takes leave to address domestic violence, harassment, sexual assault or stalking, or in the year immediately preceding the year in which an eligible employee takes leave for domesticviolence, harassment, sexual assault or stalking.
- 2. "Eligible employee" means an employee who is a victim of domestic violence, harassment, sexual assault or stalking or is the parent or guardian of a minor child or dependent who is a victim of domestic violence, harassment, sexual assault or stalking.
- 3. "Protective order" means an order authorized by Oregon Revised Statute (ORS) 30.866, 107.095(1)(c), 107.700 - 107.735, 124.005 - 124.040 or 163.730 - 163.750 or any other order that restrains an individual from contact with an eligible employee or the employee's minor child or dependent.
- 4. "Victim of domestic violence" means an individual who has been a victim of abuse as defined by ORS 107.705; or any other individual designated as a victim of domestic violence by rule adopted under ORS 659A.805.
- 5. "Victim of harassment" means an individual against whom harassment has been committed as described in ORS 166.065 and any other individual designated as a victim of harassment by rule adopted under ORS 659A.805.
- 6. "Victim of sexual assault" means an individual against whom a sexual offense has been committed as described in ORS 163.467 or 163.525; or any other individual designated as a victim of sexual assault by rule adopted under ORS 659A.805.
- 7. "Victim of stalking" means an individual against whom stalking has been committed as described in ORS 163.732; or an individual designated as a victim of stalking by rule adopted under ORS 695A.805; or an individual who has obtained a court's stalking protective order or a temporary court's stalking protective order under ORS 30.866.
- 8. "Victim services provider" means a prosecutor-based victim assistance program or a nonprofit program offering safety planning, counseling, support or advocacy related to domestic violence, harassment, sexual assault or stalking.

When applicable, the district will comply with the provisions of protected leave identified in ORS 659A.272

Domestic Violence, Harassment, Sexual Assault, <u>Bias</u>, or Stalking Leave <u>(Safe Leave)</u> – GCBDC/GDBDC to address domestic violence, harassment, sexual assault, bias, or stalking.

A<u>The</u> district (covered employer¹) shall allow an (eligible) employee² to take reasonable leave from employment for any of the following reasons:

- 1. To seek legal or law enforcement assistance or remedies to ensure the health and safety of the employee or the employee's minor child or dependent, including preparing for and participating in protective order proceedings or other civil or criminal legal proceedings related to domestic violence, harassment, sexual assault, bias, or stalking;
- 2. To seek medical treatment for or to recover from injuries caused by domestic violence or sexual assault to, or harassment or stalking of, or the commission of a bias crime against the eligible employee or the employee's minor child or dependent;
- 3. To obtain, or to assist a minor child or dependent in obtaining counseling from a licensed mental health professional related to an experience of domestic violence, harassment, sexual assault, <u>bias</u>, or stalking;
- 4. To obtain services from a victim services provider for the eligible employee or the <u>eligible</u> employee's minor child or dependent; <u>or</u>
- 5. To relocate^{$\frac{3}{2}$} or take steps to secure an existing home to ensure health and safety of the eligible employee or the employee's minor child or dependent.

The district may limit the amount of leave, if the <u>eligible</u> employee's leave creates an undue hardship on the district.

The district shall not deny leave to an <u>eligible</u> employee or discharge, threaten to discharge, demote, suspend or in any manner discriminate or retaliate against an employee with regards to promotion, compensation or other terms, conditions or privileges of employment as a result of taking such leave because the employee makes inquiries about, applies for, or takes such leave.

The <u>eligible</u> employee shall give the district reasonable advanced notice of the employee's intent<u>ion</u> to take leave unless giving advance notice is not feasible.

The district may require the <u>eligible</u> employee to provide certification that:

- 1. The employee or <u>employee's</u> minor child or dependent is a victim of domestic violence, harassment, sexual assault, <u>bias</u>, or stalking; and
- 2. The leave is taken for one of the identified purposes in this policy.

The eligible employee shall provide a certification within a reasonable time after receiving the district's request for the certification.

Sufficient certification to support a request for such leave includes:

- 1. A copy of a report from law enforcement indicating the <u>eligible</u> employee or <u>the employee's minor</u> child or dependent was a victim of domestic violence, harassment, sexual assault, <u>bias</u>, or stalking.
- 2. A copy of a protective order or other evidence from a court, administrative agency, or attorney that the <u>eligible</u> employee appeared in or <u>was-is</u> preparing for a civil, <u>or</u> criminal or administrative proceeding related to domestic violence, harassment, sexual assault, <u>bias</u> or stalking.; <u>or</u>
- 3. Documentation from an attorney, law enforcement officer, health care professional, licensed mental professional or counselor, member of the clergy, <u>employee of the Department of Justice division</u> providing victim and survivor services or a victim services provider that the <u>eligible</u> employee, or <u>the</u> employee's <u>minor</u> child or dependent was undergoing <u>treatment or</u> counseling, obtaining services or relocating as a result of domestic violence, harassment, sexual assault, <u>bias</u>, or stalking.

All records and information kept by the district regarding the employee's leave <u>under ORS 659A.270</u>– <u>659A.285</u>, including the <u>fact the employee has</u> request<u>ed</u> or obtaining of <u>obtained such</u> leave, <u>is are</u> confidential and may not be released without the express permission of the employee unless otherwise required by law. This information will be kept in a file separate from the employee's personnel file.

The employer may choose the order in which paid accrued leave is to be used when more than one type of paid leave is available, <u>including personal, sick leave</u>, or accrued vacation leave, consistent with Board policies and/or any collective bargaining agreement.

- 1. <u>"Protective order" means an order authorized by ORS 30.866, 107.095 (1) (c), 107.700 to 107.735, 124.005 to 124.040, 163.730 to 163.750 or 163.760 to 163.777 or any other order that restrains an individual from contact with an eligible employee or the employee's minor child or dependent.</u>
- 2. <u>"Victim of bias" means an individual who has been a victim of a bias crime as defined in ORS</u> 147.380; or any other individual designated as a victim of bias by rule adopted under ORS 659A.805.
- 3. <u>"Victim of domestic violence" means an individual who has been a victim of abuse, as defined in ORS 107.705; or any other individual designated as a victim of domestic violence by rule adopted under ORS 659A.805.</u>
- 4. "Victim of harassment" means an individual against whom harassment has been committed as described in ORS 166.065; or any other individual designated as a victim of harassment by rule adopted under ORS 659A.805.
- 5. "Victim of sexual assault" means an individual against whom a sexual offense has been committed as described in ORS 163.305 to 163.467, 163.472 to 163.525; or any other individual designated as a victim of sexual assault by rule adopted under ORS 659A.805.

- 6. "Victim of stalking" means an individual against whom stalking has been committed as described in ORS 163.732; an individual designated as a victim of stalking by rule adopted under ORS 659A.805; or an individual who has obtained a court's stalking protective order or a temporary court's stalking protective order under ORS 30.866.
- 7. "Victim services provider" means a prosecutor-based victim assistance program or a nonprofit program offering safety planning, counseling, support or advocacy related to domestic violence, harassment, sexual assault, bias, or stalking.
