➤ **Section 61a #4114: \$6,252**

Performance Period: 10.01.2025-09.30.2026

Carryover Allowed: No

Schools/Programs: CTE Administration

Purpose: To partially reimburse school districts for the additional costs of operating career and technical education (CTE) programs.

➤ **31aa Mental Health #4316: \$1,625,956.13**

Performance Period: 10.01.2025 – 09.30.2026

Schools/Programs: Mental Health and School Safety

Purpose: Provides per pupil funding for local school districts, both traditional public school districts and public school academies; intermediate districts; nonpublic schools; and Michigan School for the Deaf for activities to improve student mental health and improve student safety.

Purpose: The Section 99 one-time appropriation provides targeted state funding to support renovations at the Don Johnson Fieldhouse, ensuring the facility can better serve the district's Student Development Program. This allocation is intended to modernize and improve key areas of the fieldhouse so it can host expanded student programming, enhance safety and accessibility, and create a more functional environment for academic, athletic, and leadership development activities. The funding helps the district address immediate facility needs while strengthening long-term student engagement and enrichment opportunities.
