They are checking on the steel fabrication today and should have a delivery date by tomorrow

Middle School Addition:

Chris Eppes, superintendent for Alcode Plumbing, was the only supervisor on site. He said:

The rerouting of the water line was finished, but they were waiting for the City to schedule the tie-ins. The tie-ins should be completed within the next two weeks. They have not finished testing the water line yet.

They are presently installing the storm sewer and should have the catch basins poured this week

Next week they are planning on closing Green Ave, pending the City's permission, to run the storm sewer past main street
