POLICY ISSUE/SITUATION

BACKGROUND INFORMATION

On June 1, 2009, the Board adopted current policy language regarding Authority to Obligate the District (Board Policy DJ), which updates the School District's Public Contracting Rules in accordance with State Recommended Model Rules. Appropriate bidding procedures and Public Contracting Rules have been complied with before recommending the attached contract for Board approval. The following authorization of contract, subject to available budget appropriations, is a routine Board action that appears under the consent grouping of the Board agenda.


(16-624) BE IT RESOLVED that the School Board authorize the Superintendent or a designee to obligate the District for the public contract item listed in Attachment A.


CONTRACT SCOPE: Provide Metered Mail Postage Services for District Mailroom

PROJECT NAME: High School Title IX Compliance; Sunset HS

PROJECT TIMELINE: 9/2014 - 7/2016

PROJECT BUDGET: \$4,324,288

PROJECT SCOPE: Modify existing team/equipment rooms, trainer rooms, locker areas and sports team rooms to achieve equality between genders for sports programs.

CONTRACT NAME: Construction of Team Room Building at Sunset High School

SOLICITATION METHOD: Invitation to Bid (ITB# 15-0037)

CONTRACT TIMELINE: 1/2016 - 7/2016

CONTRACT SCOPE: Construct three team rooms without lockers, a locker room, and staff/ conference space in a stand-alone structure. This contract work supplements the alterations and improvements already completed for the locker rooms and team rooms in the main building.

CONTRACT AMOUNT: \$ 1,029,000

RECOMMENDATION: Authorization of award of contract to 2KG Construction, Inc.
