Superintendent Report January 2025

## **Facilities**

Ram Electric completed the electrical upgrades to the bus barn on January 21<sup>st</sup>. As part of the project, they installed additional electrical conduit between the new switch gear installed at the bus barn to what is the metal shop for further expansion if needed. This project completed all of the items from our summer project list. Over the winter break, the maintenance staff completed some necessary repairs to the tile in the student restrooms and locker rooms and some plumbing repair. We also painted the floors of the locker rooms and laundry rooms. We are replacing fluorescent light in the bus barn with LED lights that were not part of the summer upgrade. We also have done this in the metal shop. I have included a report submitted by Jim Frost on the timber located on our property. We will follow up on this report and look at finding a contractor to remove the scotch broom located in those areas.

## Facilities Committee.

We held another facility committee on January 23, 2025. Garner Miller presented a conceptual drawing from the input he received from the last meeting and a very rough cost estimated based on the input. The next meeting is scheduled for February 4, 2025.

## **Grants:**

We applied and received CTE grants this month. Our CTE Construction program received \$22,000, CTE High Demand received \$12,000. Four staff members submitted CPEG Community Grants for a total amount of \$1,900.

We were notified by the Department of Ecology that we received another "Stacking" Electric Bus Grant. This grant may be applied to our current grant to further deferrer the cost of the next electric school bus that is on order and for frustrate. This grant amount is for \$165,000 towards the purchase of the bus and an addition \$50,000 for unfractured.

## **Transportation:**

We were able to surplus and sell both Dodge mini vans. One to Olympia School District and the other to Rochester School District. We have received both Ford 10 passenger vans as of 1/21/15.
